- Modification to Bid Form, Section 12, Part 1:
 - Complete System. Except as otherwise provided herein, Subcontractor shall design, furnish and install eighteen (18) APTA heavy duty transit type machine room-less building elevators for the north and south gates and twenty two (22) APTA heavy duty transit type machine room-less building elevators for the Core and six (6) pending elevators for the Core including all required components for a complete system (fixed hoistway equipment, moving hoistway equipment, control equipment, machine room equipment, elevator fixture and fittings, etc.) in accordance with the Contract Documents, drawings and specifications. The drawings and specifications indicate the number of elevators, stops, capacities, performance, etc. Subcontractor acknowledges that the drawings have not been fully coordinated and that the elevators, locations, orientation, machine room locations and layout may need to be altered to accommodate Subcontractor's Work at no additional cost. This scope is based upon the specified performance of the elevators.
 - o Furnish and install eighteen (18) APTA heavy duty transit type esclators for the north and south gates, twenty two (22) APTA heavy duty transit type esclators for the Core including all required components for a complete system (truss mounting angles and intermediate truss supports angles, control equipment, escalator fixture and fittings, etc.) in accordance with the Contract Documents, drawings and specifications. The drawings and specifications indicate the number of escalators, capacities, performance, etc. Subcontractor acknowledges that the drawings have not been fully coordinated and that the escalators, locations, orientation and

layout may need to be altered to accommodate Subcontractor's Work at no additional cost. This scope is based upon the specified performance of the escalators.

 - 2 new two (2) stop elevators
