Part 3 - Questions from Potential Bidders

- Question: Section 1-15.1. of the Instructions to Bidders states that "MWBE bidders must be certified by the City of Los Angeles, Caltrans, or Los Angeles County Metropolitan Transportation authority. No other certifying agencies will apply..." We have been recently informs that a City of Los Angeles representative is telling people who are attempting to apply for certification that they do not need to register for MBE certification if they hold a certification from the Southern California Minority Business Development Council, Inc. The City of Los Angeles Representative states that Southern California Minority Business Development Council, Inc. certification is acceptable for all city projects, including projects at LAX. Will you please confirm that MBE certification from the Southern California Minority Business Development Council, Inc. will be acceptable in achieving project goals?
- Answer: Yes. Refer to our website: <u>www.walshaustinjv.com</u>. In the M/WBE Program, you will find the "Walsh Austin Joint Venture M/WBE Inclusion Program." Pages 2 and 3 of this program includes the certifications resources.
- Question: The Instructions to Bidders states that a Bid Bond is required to accompany all bids. There is no Bid Bond form included in the documents. Will a Bid Bond form be issued?
- Answer: No. Subcontractor can use their own Bid Bond form.
- Question: Specification Section 23 6416-10.1.1 and 2 for the evaporator and Section 23 6416-10.1.1 for the condenser requires anodes and protective coatings on both heat exchangers. The condenser water is chilled water return from the CUP separated with a heat exchanger. It is a closed loop. The chilled water system is also a closed loop. Anodes and protective coatings are only required when the water quality is more corrosive than what typical water treatment system will handle or when you are using condenser water from a river or corrosive environment. How do we proceed? Answer: Price per plans and specs.
- Question: On drawing M43N3 match lines are shown dividing the page on the north side of the match line. It states limit of work but the note is in the same area they call out FCU-N20 and FCU-N18, which are on the fan coil unit schedule on drawing M0010N. Should the subcontractor figure any scope

of work in this area including FCU-N20 and FCU-N18. Answer: Yes. Include FCU-N20 and FCU-N18 and all associated work in scope.

Question: Section 22 1316, paragraph 3.2 D1 & E1 require vent piping above ground to be service class cast iron soil pipe and fittings with gaskets. Will hubless cast iron with standard couplings or heavy duty couplings be acceptable.

Answer: No. Bid per plans and specs.
