Trade Specific Networking Event

Once again, we are hosting a specific networker event and we are reaching out to the local M/W/OBE subcontracting community. All of us at Walsh Austin Joint Venture are dedicated and continue to work towards the inclusion of M/W/OBE firms on our Bradley West Gates Project at LAX. Three bid packages were released last Wednesday; in our efforts to further engage the minority and women-owned business we are holding a **“Trade Specific” Networking event** on Thursday, December 3, 2009 from 8am – 10am. The event is currently scheduled to take place at the LAX Crown Plaza on 5985 West Century Blvd. Below please find the information on the current bid packages just released:

LAX Bradley West Gates – TRADE SPECIFIC Networking Event

M/W/OBE Questionnaire applications are currently being accepted by the Walsh Austin Joint Venture to participate in the bidding opportunity for the construction work associated the following bid packages:

Bid Package 5 – Turnkey Cast in Place Concrete (sub-tiers may include reinforcement, formwork, hoisting, rigging, waterproofing)

Bid Package 6 - Elevators, Escalators, & Moving Walkways

Bid Package 7 - Concourse Construction Package (sub-tiers may include demolition, precast, shoring, and other utilities)

PROJECT INFORMATION

The Bradley West Gates Project will replace the current concourses with nineteen (19) gates to the west of the existing Tom Bradley International Terminal. The development of the Bradley West Gates will include four (4) major components:

- New North Concourse
- New South Concourse
- Demolition of Existing TBIT Concourses
- Construction of Ancillary Facilities, Utilities and Substructures

The project includes approximately 500,000 sqft of new concourses built adjacent to the existing TBIT concourses which will connect with the TBIT core building. The project has a goal of achieving LEED Silver certification.

To be considered for bidding opportunities on any of these projects, each subcontractor/vendor must complete Walsh Austin’s “SUBCONTRACTOR QUESTIONNAIRE”. All certified M/WBE firms are encouraged to submit questionnaire information in advance, so any addition information that may be required can be addressed prior to bid day. Contractors and vendors may obtain a questionnaire from the project website www.walshaustinjv.com.

Delaying the QUESTIONNAIRE process could result in missed bid opportunities. Completion of the pre-qualification questionnaire does not guarantee that the applicant will be placed on Walsh Austin JV’s bid list or selected, but will start the process of consideration for bidding opportunities that match up with the qualifications. The construction of this project will proceed only if the project is approved pursuant to the required environmental review under California Environmental Quality Act (CEQA).
