#### **DESCRIPTION OF SCOPE**

Renovation of the existing Tom Bradley International Terminal (TBIT). Bid Package 49-02 includes early concrete scope necessary to open the new Bradley West Core. The balance of the Renovation will be in Bid Package 41 to be issued in the future. All existing operations (i.e. passenger check-in, baggage claim, security check points, customs, administrative, etc.) shall remain fully operational during the renovation. Accordingly, the renovation will be performed in multiple phases and during off-hours. Renovation includes new DWP/Transformer yard, office and other interior spaces, storage rooms and key utility rooms.
